TINGKAT DISIPLIN BELAJAR ANAK DI MASA PANDEMI
(Studi Kuantitatif Pada Siswa Sekolah Dasar St. Theresia 1)

Penelitian ini bertujuan untuk: 1. Mendeskripsikan seberapa tinggi tingkat disiplin belajar anak di masa pandemi. 2. Mengidentifikasi item-item yang memiliki skor tertinggi pada perilaku disiplin diri anak di masa pandemi.

Jenis penelitian ini adalah penelitian kuantitatif. Subjek penelitian ini adalah siswa SD Santa Theresia 1 Pangkalpinang berjumlah 50, siswa ini dibagi menjadi 2 kelas yaitu kelas IV berjumlah 25 siswa dan kelas V berjumlah 25 siswa. Pengumpulan data menggunakan skala disiplin belajar anak di masa pandemi dengan 20 item valid dan memiliki indeks reliabilitas 0,867. Skala disusun berdasarkan aspek-aspek disiplin belajar anak di masa pandemi, yaitu: (1) Disiplin belajar di rumah; (2) Disiplin belajar di sekolah. Disiplin belajar anak di masa pandemi dianalisis menggunakan diskriptif kategorisasi dan diskriptif presentase.

Hasil penelitian ini menunjukkan: (1) tingkat disiplin belajar anak di masa pandemi siswa SD Santa Theresia 1 Pangkalpinang mayoritas berada pada kategorisasi sangat tinggi dengan presentase 64,4%, 10,2% berada pada kategorisasi tinggi, 10,2% berada pada kategorisasi sedang, 8,2% berada pada kategorisasi rendah, 2,0% berada pada kategorisasi sangat rendah; (2). Hasil analisis item tingkat disiplin belajar di masa pandemi sangat tinggi dengan 14 item, 4 item berada pada kategori tinggi, dan 1 item berada pada kategori sedang serta rendah.

**THE LEVEL OF DISCIPLINE IN CHILDREN'S LEARNING DURING THE

The purposes of this research are 1. To describe how high the level of discipline in children's learning is during the pandemic. 2. To identify items that have the highest score of discipline behavior children's self during this pandemic.

This is a quantitative research. The subject of this research is students of St. Theresia 1 Pangkalpinang Elementary School which amounts 50 students, these students are divided into 2 classes which are from IV class that amounts to 25 students, and V class that amounts to 25 students. Data collection uses a children's learning discipline scale during the pandemic with 20 valid items and has a reability index of 0.867. The scale is compiled based on aspects of children's learning discipline during the pandemic, namely: (1) Discipline of learning at home; (2) Discipline of learning at school. Children's learning discipline during the pandemic was analyzed using descriptive and percentage descriptive categorizations

The results of this study indicate: (1) The high level of discipline in the students of St. Theresia 1 Pangkalpinang is in the very high categorization with a percentage of 64.4%, 10.2% is in the high categorization, 10.2% is in the medium categorization, 8.2% is in the low categorization, 2.0% is in the low categorization very low; (2). The results of the analysis of the child's learning discipline level during the pandemic were very high with 14 items, 4 items in the high category, and 1 item in the medium and low categories.
