

ABSTRAK

Penelitian ini mengkaji tentang tindak tutur direktif dalam serial film “*Imperfect The Series 2*” karya Naya Anindita. Tuturan-tuturan yang menjadi data penelitian ini merupakan tuturan para tokoh di dalam serial film “*Imperfect The Series 2*” karya Naya Anindita. Tujuan penelitian ini yaitu: 1) mendeskripsikan bentuk-bentuk tindak tutur direktif dalam serial film “*Imperfect The Series 2*” karya Naya Anindita, dan 2) mendeskripsikan makna pragmatik tindak tutur direktif dalam serial film “*Imperfect The Series 2*” karya Naya Anindita.

Penelitian ini termasuk ke dalam jenis penelitian deskriptif kualitatif. Sumber data penelitian ini adalah serial film “*Imperfect The Series 2*” karya Naya Anindita. Bentuk sumber data yang digunakan adalah audio visual. Data penelitian yang diambil berupa tuturan-tuturan tokoh di dalam serial film “*Imperfect The Series 2*” karya Naya Anindita yang mengandung tindak tutur direktif. Teknik pengumpulan data penelitian ini menggunakan teknik simak bebas libat cakap dan catat. Proses mengumpulkan data, mengidentifikasi, dan mengklasifikasi data-data, peneliti lakukan sesuai dengan bentuk-bentuk tindak tutur direktif dan makna pragmatiknya. Kemudian, peneliti menganalisis data-data yang diperoleh dengan kajian pragmatik, tindak tutur direktif, dan makna pragmatik. Selanjutnya, peneliti mengidentifikasi dan menguraikan data ke dalam bentuk tabulasi data.

Berdasarkan analisis yang telah dilakukan, peneliti menemukan bentuk-bentuk tindak tutur direktif dan makna pragmatik tindak tutur direktif. Terdapat sembilan bentuk tindak tutur direktif yang ditemukan, yaitu: direktif meminta, direktif melarang, direktif menasehati, direktif menanyakan, direktif memerintah, direktif dorongan, direktif menyarankan, direktif mengancam, dan direktif mengajak. Kemudian, makna pragmatik yang ditemukan berjumlah sepuluh makna, yaitu: makna pemberitahuan, makna menasehati, makna menegaskan, makna menyuruh, makna menawarkan, makna mengancam, makna mengajak, makna meminta, makna melarang, dan makna menyarankan.

ABSTRACT

This study examines directive speech acts in the film series "Imperfect The Series 2" by Naya Anindita. The utterances that become the research data are the utterances of the characters in the film series "Imperfect The Series 2" by Naya Anindita. The aims of this study are: 1) to describe the forms of directive speech acts in the film series "Imperfect The Series 2" by Naya Anindita, and 2) describing the pragmatic meaning of directive speech acts in the film series "Imperfect The Series 2" by Naya Anindita.

This research is included in the type of qualitative descriptive research. The source of this research data is the film series "Imperfect The Series 2" by Naya Anindita. The form of data source used is audio-visual. The research data was taken in the form of the utterances of the characters in the film series "Imperfect The Series 2" by Naya Anindita which contains directive speech acts. The technique of collecting data in this study uses the technique of free-standing, conversational and note-taking. The process of collecting data, identifying, and classifying data, researchers do according to the forms of directive speech acts and their pragmatic meanings. Then, the researcher analyzed the data obtained by examining pragmatics, directive speech acts, and pragmatic meanings. Next, the researcher identifies and describes the data in the form of data tabulations.

Based on the analysis that has been done, the researcher found the forms of directive speech acts and the pragmatic meaning of directive speech acts. There are nine forms of directive speech acts found, namely: directive asking, directive forbidding, directive advising, directive asking, directive ordering, directive encouraging, the directive suggests, the directive threatens, and the directive invites. Then, the pragmatic meanings found amounted to ten meanings, namely: the meaning of notification, the meaning of advising, the meaning of affirming, the meaning of ordering, the meaning of offering, the meaning of threatening, the meaning of inviting, the meaning of asking, the meaning of forbidding, and the meaning of suggesting.
