

ABSTRAK

TINGKAT DISIPLIN GURU EKONOMI DALAM MELAKSANAKAN TUGAS; KASUS PADA GURU-GURU EKONOMI DI KOTA YOGYAKARTA 2018

Penelitian ini bertujuan untuk menganalisis tingkat disiplin guru ekonomi SMA dalam melaksanakan tugas di Kota Yogyakarta ditinjau dari aspek: (1) ketepatan waktu dalam bekerja, (2) pemanfaatan sarana dan prasarana sekolah, (3) kemampuan menghasilkan pekerjaan yang memuaskan, dan (4) kepatuhan terhadap peraturan sekolah.

Penelitian ini merupakan penelitian deskriptif kuantitatif. Penelitian dilaksanakan di 28 SMA di Kota Yogyakarta. Populasi penelitian meliputi seluruh guru mata pelajaran ekonomi SMA di Kota Yogyakarta. Responden penelitian berjumlah 47 guru mata pelajaran ekonomi SMA di Kota Yogyakarta. Teknik penarikan sampel pada penelitian ini adalah teknik sampel jenuh. Teknik pengumpulan data menggunakan kuesioner. Analisis data dilakukan dengan analisis statistik deskriptif.

Hasil analisis data menunjukkan bahwa: (1) dalam hal ketepatan waktu, sebagian besar (51,1%) guru termasuk dalam kategori “disiplin”, (2) dalam hal pemanfaatan sarana dan prasarana sekolah, sebagian besar (68,1%) guru termasuk dalam kategori “disiplin”, (3) dalam hal menghasilkan pekerjaan yang memuaskan, sebagian besar (76,6%) guru termasuk dalam kategori “sangat disiplin”, dan (4) dalam hal kepatuhan terhadap peraturan sekolah, hampir semua (97,9%) guru termasuk dalam kategori “sangat disiplin”.

ABSTRACT

THE TEACHER DISCIPLINE LEVEL IN CONDUCTING THEIR DUTIES AMONG SENIOR HIGH SCHOOLS ECONOMICS TEACHERS IN YOGYAKARTA 2018

The study aims to analyze the discipline level of Senior High School Economics Teachers in conducting their duty in Yogyakarta. This study was conducted based on the following perspectives: (1) adherence to punctuality during the working hours; (2) operation of school facilities; (3) satisfactory job performance; and (4) obedience to school regulation.

This research is a quantitative descriptive study. This research was conducted in 28 senior high schools in Yogyakarta. The research population was all the senior high school economic teacher. The respondent of the study covered 47 senior high school economics teachers in Yogyakarta. The research sampling technique is saturation sampling technique. The data collection method is a questionnaire. Furthermore, in analyzing the data the descriptive statistics analysis technique was implemented.

The results of the study show that: (1) from the aspects of adherence to punctuality during the working hours, the discipline level of most the teachers (51,1%) belongs to the “discipline” category; (2) from the aspects of operation of school facility, the discipline level of most the teachers (68,1%) belongs to the “discipline” category; (3) from the aspects of satisfactory job performing, the discipline level of most the teachers (76,6%) belongs to the “very discipline” category; and (4) from the aspects of obedience to school, the discipline level of most the teachers (97,9%) belongs to the “very discipline” category.
