Penelitian berjudul "Wacana Keluku Video di Kanal Youtube MPL Indonesia *Season 9*" ini memiliki dua tujuan. Pertama, mendeskripsikan jenis kalimat dalam Wacana Keluku Video di Kanal Youtube MPL Indonesia *Season 9*. Kedua, Mendeskripsikan jenis tindak tutur Wacana Keluku Video di Kanal Youtube MPL Indonesia *Season 9*.

Objek penelitian ini adalah jenis kalimat dan tindak tutur yang digunakan dalam Wacana Keluku Video di Kanal Youtube MPL Indonesia *Season 9*. Data dari penelitian ini berupa tuturan yang terdapat di Keluku Video di Kanal Youtube MPL Indonesia *Season 9*. Adapun penelitian ini dilakukan lewat tiga tahapan, yaitu pengumpulan data, analisis data dan penyajian hasil analisis data.

Tahap pengumpulan data dilakukan dengan menggunakan teknik dasar berupa teknik sadap dan beberapa teknik lanjutan berupa simak bebas libat cakap, yaitu teknik catat. Tahap kedua, data dianalisis dengan menggunakan metode agih. Data yang telah terkumpul dianalisis lewat teknik baca markah dan teknik perluas. Hasil analisis data disajikan dengan metode informal.

Hasil penelitian tentang jenis kalimat dan jenis tindak tutur Wacana Keluku Video di Kanal Youtube MPL Indonesia *Season 9* adalah sebagai berikut. Pertama jenis kalimat yang digunakan meliputi jenis kalimat deklaratif, imperatif, yang terdiri dari imperatif halus, imperatif ajakan, imperatif harapan, imperatif larangan, imperatif peringatan, dan imperatif pembiaran, serta interrogatif. Kedua, jenis tindak tutur yang digunakan adalah tindak tutur ilokusioner atau ilokusi yang mencakup tindak tutur representatif, direktif, komisif, ekspresif, dan deklarasi.

The research, entitled "Video Thumbnails Discourse on the MPL Indonesia Season 9 Youtube Channel," has two objectives. First, it describes the types of sentences in the Video Thumbnails Discourse on the MPL Indonesia Season 9 Youtube Channel. Second, it describes the types of speech acts in the Video Thumbnails Discourse on the MPL Indonesia Season 9 Youtube Channel.

This research aims to identify the types of sentences and speech acts used in the video thumbnails discourse on the MPL Indonesia Season 9 Youtube channel. The data from this study is in the form of speeches contained in the video thumbnails on the MPL Indonesia Season 9 Youtube channel. This research was conducted in three stages: data collection, data analysis, and the presentation of the analysis results.

The data collection stage was carried out using basic techniques in the form of tapping techniques and several advanced techniques in the form of free-lance viewing, namely note-taking techniques. In the second stage, the data were analyzed using the distribution method. The data that has been collected is analyzed by using mark-reading and expanding techniques. The results of data analysis are presented using an informal method.

The results of research on the types of sentences and types of speech acts in video thumbnails discourse on the MPL Indonesia Season 9 Youtube channel are as follows: First, the types of sentences used include declarative, imperative (consisting of subtle imperatives, solicitation imperatives, hope imperatives, prohibition imperatives, warning imperatives, and imperatives of omission), as well as interrogative. Second, the types of speech acts used are illocutionary, which include representative, directive, commissive, expressive, and declaration speech acts.
