Skripsi ini membahas kalimat imperatif dalam novel Gadis Pantai karya Pramoedya Ananta Toer. Kajian kalimat imperatif ini dilakukan untuk mengetahui jenis dan fungsi kalimat imperatif dalam novel Gadis Pantai karya Pramoedya Ananta Toer.

Metode pengumpulan data yang digunakan dalam penelitian ini adalah metode simak atau metode observasi. Metode analisis data yang digunakan adalah metode padan, metode yang alat penentunya di luar terlepas dan tidak menjadi bagian dari bahasa (langue) yang bersangkutan. Metode penyajian hasil analisis data yang digunakan dalam skripsi ini adalah metode informal atau verbal adalah penyajian kaidah penggunaan bahasa dengan kata-kata atau kalimat.

Hasil penelitian ini adalah jenis-jenis kalimat imperatif dalam novel Gadis Pantai yang ditemukan sebagai berikut : kalimat perintah ditemukan sebanyak dua belas (12), kalimat persilahan ditemukan sebanyak lima (5), kalimat ajakan ditemukan sebanyak enam (6), dan kalimat larangan ditemukan sebanyak dua puluh enam (26). Fungsi kalimat imperatif dalam novel Gadis Pantai yang ditemukan sebagai berikut : fungsi memerintah ditemukan sebanyak tujuh (7), fungsi mengundang ditemukan sebanyak sebelas (11), fungsi melarang ditemukan sebanyak dua puluh lima (25).

ABSTRACT

This thesis discusses the imperative sentence in the novel *Gadis Pantai* by Pramoedya Ananta Toer. This imperative sentence study was conducted to determine the type and function of imperative sentences in the novel *Gadis Pantai* by Pramoedya Ananta Toer.

The data collection method used in this study is the simak method or observation method. The method of data analysis used is the padan method, a method whose determinant is outside detached and does not become part of the language (*langue*) in question. The method of presenting the results of data analysis used in this thesis is an informal or verbal method is the presentation of the rules of use of language with words or sentences.

The results of this study are the types of imperative sentences in the novel *Gadis Pantai* which were found as follows: the command sentence was found as many as twelve (12), the term of the term was found as many as five (5), the sentence of invitation was found as many as six (6), and the prohibition sentence was found as many as twenty-six (26). The imperative sentence function in the novel *Gadis Pantai* is found as follows: the commanding function is found as many as seven (7), the invite function is found as many as eleven (11), the prohibit function is found as many as twenty-five (25).
