

## ABSTRAK

Penelitian ini bertujuan untuk: (1) Menganalisis efektivitas pelaksanaan monitoring dan evaluasi kegiatan Implementasi Renstra; (2) Menganalisis efektivitas alat yang digunakan dalam pelaksanaan monitoring dan evaluasi kegiatan Implementasi Renstra; (3) Mereview pelaksanaan monitoring dan evaluasi Implementasi Renstra di Perkumpulan Strada. Metode penelitian yang digunakan adalah penelitian kualitatif. Objek penelitiannya adalah Perkumpulan Strada. Pemilihan narasumber menggunakan metode *purposive sampling* yaitu pihak-pihak yang berhubungan langsung dengan pelaksanaan monitoring dan evaluasi di Perkumpulan Strada. Narasumber penelitian ini adalah Wakil Direktur Pendidikan, Tiga (3) Kepala Bagian, Pengawas Sekolah, dan empat (4) Kepala Sekolah. Metode pengumpulan data menggunakan metode wawancara mendalam, studi dokumentasi, dan FGD. Analisis data menggunakan teori menurut Moleong yang terdiri dari tiga tahap yaitu pemrosesan satuan, kategorisasi termasuk pemeriksaan keabsahan data, dan penafsiran data. Hasil penelitian membuktikan bahwa (1) Pelaksanaan monitoring dan evaluasi di Perkumpulan Strada telah efektif pada saat dilaksanakan oleh Tim Monev; (2) Alat monitoring dan evaluasi yang digunakan saat ini efektif dalam menggali data dari sekolah; (3) Pelaksanaan monitoring dan evaluasi yang efektif harus memenuhi tiga tahap yaitu perencanaan, pelaksanaan, dan pelaporan. Secara umum pelaksanaan monitoring dan evaluasi Implementasi Renstra Perkumpulan Strada telah memenuhi tiga tahap tersebut ketika dilaksanakan oleh Tim Monev.

## ABSTRACT

*This study aims to: (1) Analyze the effectiveness of the implementation of monitoring and evaluation of Strategic Plan Implementation activities; (2) Analyzing the effectiveness of the tools used in the monitoring and evaluation of Strategic Plan Implementation activities; (3) Reviewing the implementation of monitoring and evaluation of Strategic Plan Implementation at the Strada Association. The research method used is qualitative research. The object of the research is the Strada Association. The selection of sources using purposive sampling method, namely the parties who are directly related to the implementation of monitoring and evaluation at the Strada Association. The resource persons for this research were the Deputy Director of Education, Three (3) Heads of Sections, School Supervisors, and four (4) Principals. Data collection methods used in-depth interviews, documentation studies, and FGDs. Data analysis uses theory according to Moleong which consists of three stages, namely unit processing, categorization including checking the validity of the data, and interpreting the data. The results of the study prove that (1) the implementation of monitoring and evaluation at the Strada Association has been effective when carried out by the Monev Team; (2) The monitoring and evaluation tools currently used are effective in extracting data from schools; (3) The implementation of effective monitoring and evaluation must fulfill three stages, namely planning, implementation, and reporting. In general, the implementation of monitoring and evaluation of the Strategic Plan of the Strada Association has fulfilled these three stages when carried out by the Monitoring and Evaluation Team.*
